The Sustainability Department at UAC is a newly formed entity with a distinct mission and scope, designed to foster innovative practices and solutions unencumbered by the company's historical approaches or traditions. This freedom enables the team to adopt new strategies, though it also requires a comprehensive evaluation across the company to establish a baseline for its performance. Future environmental, social, and governance goals will be assessed relative to this baseline.

Consequently, this inaugural Sustainability Report for 2023 will primarily document the findings from this evaluation process and outline key achievements and initial measures already put into place.

Therefore, the sustainability team aims to advocate for a more integrated, systems-based approach.

The environmental and social aspects of sustainability are highly intricate and ever-evolving systems. Each action we undertake carries a corresponding impact. Given the complexity and variety of these issues, it is clear that our focus needs to move from isolated topics to tackling multiple interconnected issues at once. UAC is committed to incorporating environmental and social factors by adopting the long-term, holistic perspective that characterizes systems thinking. Consequently, the sustainability team will concentrate on developing new operational methods, innovative strategic frameworks, and, importantly, on encouraging interaction and involvement among UAC employees.

UAC has established a strong base for developing its sustainability strategy. Although having a dedicated sustainability department is crucial for UAC, the company has long been incorporating sustainability considerations across its various divisions and facilities. Key achievements so far include:

## Material management

Within its process and material management, UAC seeks to reduce resource consumption andto implement circular economy principles.

Usage of recycled PP (rPP) pellets to reduce the amount of virgin PP material applied in operations.

Reduction of paper and print colour toner consumption by only printing brochures in English and providing a digital system for document/invoice management.

## Waste management

UAC has a waste management system in placein its production halls and office facilities to allow waste separation and recycling.

Facilitation of the differentiated collection of scrap cutting materials to repurpose cutting inserts, if still operational.

Utilization, and therefore recycling, of single-use plastic packaging material in production processes.

Preparation of communication materials to encourage staff to increase recycling fidelity to support the waste management measures.

Collection and composting of organic waste in the offices in Jeddah.

## Energy management

UAC has implemented various energy initiatives and further aims to increase the prevalence of renewable energy utilization in the company.

Promotion of renewable energy by installing Solar Panels lighting system in the factory as well as in the offices.

Installation of LED lighting in the production halls and enhancement of the insulation (e.g. windows and roofs) further reduces energy consumption.

Installation of automatic lighting sensors to contribute to lowering energy consumption.

Reduction of energy consumption in the lamination machines by using special additives in the production process for more energy-efficient models and to allow for savings between 35-40%.

Focusing on sustainable investment products in UACs security holdings to stay true to its environmental objectives and to exercise an environmentally-conscious business culture.

Implementation of regular maintenance and energy efficiency checks to ensure that all equipment is functioning properly, and to identify any potential leakages or inefficiencies.


## **Transport & logistics**

Maximizing travel efficiencies and leveraging remote working possibilities is an increasingly important area of focus for UAC.

Facilitation of remote working options, building on the lessons learned from the COVID-19 pandemic and the increased capacity for remote working.

Reduction of business travel for most employees by providing an excellent living for individuals and family nearby the industrial city to reduce the travels.

Promotion of public transport and/or car sharing where possible and provision of public-transport tickets.



### Water management

Water is a crucial resource which is vital for life. As with all other forms of consumption, water usage is carefully monitored in UAC.

Implementation of regular maintenance checks of water consumption to detect any potential leaks early.

## Social engagement

UAC places importance on social engagementand supports the communities in which it operates invarious ways.

## UAC & CIRCULARITY

United Accredited Company (UAC) has a longstanding commitment to sustainability, having embraced the principles of circularity for over three decades. Early on, UAC introduced recycling practices into its production processes and established dedicated divisions focused on recycling technology and sustainable solutions. Central to UAC's approach is the circular economy concept, a regenerative model where waste products are reused as inputs in a closed-loop system, aimed at reducing natural resource consumption, minimizing waste, and fostering sustainable growth and employment. This approach also addresses ongoing environmental challenges while maintaining the value of products, materials, and resources for as long as possible.

UAC applies these circular principles throughout its operational processes, with several initiatives demonstrating the commitment of its divisions to sustainable practices. For instance, UAC collaborated with local partners in the Jeddah region to provide children with school supplies packaged in materials made of 100% recycled polypropylene (PP). This initiative ensures that packaging is made from newly created PP materials composed of 100% recycled, unprinted mono material that can be perpetually recycled into food-grade quality products. The used materials are collected following delivery, then washed and processed using advanced recycling technology developed by UAC. This project significantly reduces the amount of packaging waste generated annually and has earned UAC recognition with several prestigious environmental awards.

Beyond its operational efficiencies, UAC promotes environmental awareness through workshops and seminars in local schools and community centres, educating young people and residents about the importance of recycling and sustainable living. The company also invests in state-of-the-art technology to enhance its recycling processes, incorporating innovative machinery that optimizes the use of materials and energy.

Additionally, UAC prioritizes suppliers who adhere to environmentally friendly practices, ensuring that the entire supply chain aligns with its sustainability goals. This proactive approach extends to partnerships with local governments and non-profits, focusing on large-scale projects that promote water conservation, energy efficiency, and waste reduction, contributing significantly to regional sustainability goals.

Through comprehensive initiatives, ongoing commitment to innovation, and community engagement, UAC not only enhances its corporate image but also makes a profound impact on sustainable development, reinforcing its position as a leader in corporate responsibility in the environmental and societal spheres.

## Stakeholder Engagement

UAC has already begun identifying the key sustainability themes that are most significant to its stakeholders, aiming to make the company's sustainability initiatives inclusive and participatory right from the outset. To achieve this, a stakeholder engagement survey was initiated and shared with employees, partners, customers, suppliers, agents, and other relevant groups. This survey is intended to collect extensive and diverse input and feedback on the crucial sustainability issues for UAC, from the viewpoint of its varied stakeholders.

In 2024, UAC will enhance its data collection efforts through stakeholder dialogues conducted during open house events at its facilities. incorporating direct qualitative interviews. Future initiatives will concentrate on applying these insights, with the results highlighted being in upcoming UAC sustainability reports.

## **Ongoing initiatives**

Several initiatives are currently being planned and developed. Future projects and programs will be guided by the results of the sustainability survey. The sustainability team will apply these findings within UAC, facilitating their adoption and implementation where suitable. To ensure ongoing support for our employees and to prioritize their wellbeing, the following measures are currently in development:

## Sustainability Reporting

Quantitative metrics are crucial for establishing UAC's baseline sustainability performance. After this baseline is set, key performance indicators (KPIs) will be developed to measure the company's progress and identify areas needing targeted improvement. Future reports will feature these KPIs, with each sustainability report covering data and best practices from the entire previous year. For example, the 2024 Sustainability Report will present data and success stories from 2023.

The initiatives undertaken in 2023 have resulted in a decrease in water consumption by 10% compared to 2022. Continued focus on water management strategies will be essential to achieving further reductions and sustainability goals.
